Officer reports were given County Treasurer, Twyla Bailey; Supervisor of Assessments, Hope Weber; County Engineer, Justin Childress; County Sheriff, Bill Rutan; and County Clerk, Fayrene Wright. Written reports were submitted by the Regional Office of Education and the Public Defender's Office. (Reports page 1381)

County Treasurer, Twyla Bailey reviewed reports and explained the content for new board members. She reported that she had received State salary reimbursements for the State's Attorney, Public Defender and Supervisor of Assessments for September. Reimbursements for October and November are still outstanding. Per Board Resolution she reported on the range of tax rates for the most recent tax cycle. There are 70 different tax rates in Crawford County. The average tax rate is 7.9401%. The lowest rate is a small section of Robinson Township located on the southwest side of Route 33 south of Gordon. It is 6.3199%. The highest rate is 10.0303% and is in the Village of Palestine, LaMotte Township.

Supervisor of Assessments, Hope Weber reported that per Resolution 2001-R-001 she is required to report to the Board each December the average percentage change in EAV for the previous three years. She reported as follows: 2014 EAV - \$401,118,225 an increase of 1.068%; 2015 EAV - \$423,010,720 an increase of 1.055%; 2016 EAV - \$430,521,256 an increase of 1.018%; and 2017 EAV - \$447,636,407 an increase of 1.040%. Hope also spoke about the Board of Review appointments on the Agenda. Each Board of Review member serves a two year term. Appointments are to be staggered. The dates on these appointments will help in getting the rotation back on cycle as outlined in Statutes.

County Engineer, Justin Childress reviewed items requiring approval. The Purchase Agreement for the dump trucks approves the financing for the purchase. Justin reported that there is a specific statute that applies only to the Highway Department that allows the Department to borrow money. The Resolution to Post Weight Limits allows him to temporarily post weight limits on County roads. The posting cannot exceed 90 days. The Resolution for 2019 County & Township Maintenance allows for the purchase of materials.

MOTION: Kip Randolph moved to approve the Resolution for the Lease Agreement for the Purchase of Highway Department Dump Trucks. George Bohman seconded the motion. Motion carried unanimously upon roll call.(Agreement page 1437)

MOTION: Clint Williamson moved to approve the Resolution for Weight Limits on County Roads. Don Goupil seconded the motion. Motion carried unanimously upon roll call. (Resolution page 1438)
