Minutes of Proceedings "1 of 3" Crawford County Board Thursday, September 12, 2013

The members of the Crawford County Board met in regular session Thursday, September 12, 2013 Chairman Gareld Bilyew called the meeting to order at 6:00 p.m.

Pledge of Allegiance was given by all, followed by a moment of silence and prayer by Don Richart.

Upon roll call Terry McCoy, Don Richart, Allen Price, Gareld Bilyew, David Fulling, Steve Rich, Robin Guyer, Shirley Treadway and Donnie Lachenmayr were present. Toni Earleywine was absent.

Shirley Treadway made a motion to approve the minutes of the August 8, 2013 County Board meeting. Robin Guyer seconded the motion. Motion carried unanimously upon roll call.

Shirley Treadway made a motion to approve the claims as presented with exception of 4 claims held for further consideration. Allen Price seconded the motion. Gareld Bilyew read a statement concerning denied claims (see attached Statement) and recommended the motion on the table be approved. Motion carried unanimously upon roll call. (Statement p.) (Claims p.)

Officer reports were given by Hope Weber-Supervisor of Assessments, Patty Lycan – County Clerk, Todd Liston-Sheriff, Justin Childress-County Highway Engineer, Jay Holtzhouser-Public Defender, Matthew Hartrich-State's Attorney and Ken Pryor-EMA Coordinator.

Gareld Bilyew stated that the approval of the Treasurer's Report will be held until the October 10, 2013 Board meeting.

David Fulling made a motion to approve the transfer of \$7,500 from the CCDA Revolving Loan Fund to the General Fund for administrative fees for June, July & August 2013. Steve Rich seconded the motion. Motion carried unanimously upon roll call. (Report p.)

Hope Weber- Supervisor of Assessments reported that Becky Phillips (upon moving to Georgia) has resigned from the Board of Review.

Justin Childress-County Highway Engineer presented an agreement for the County Engineer Salary noting that ½ of the engineer's salary is paid from State funds.

Grant monies are being applied for that will assist in the training and upgrading of our county website through a program call "eGovernment Opportunity".

Gareld Bilyew-County Board Chairman reported that the county will soon need a new "public guardian" and "public administrator". The position is appointed by the governor and confirmed by the State Senate. The guardian serves as guardian for disabled adults who do not have family to act as a guardian while the administrator serves as executor of the estate of Illinois residents who die without wills and without family to serve as executors. The same person could serve as both. (Letter p.)
