The members of the Crawford County Board met in regular session Thursday, October 13, 2011. Chairman Joe Bliss called the meeting to order at 6:00 p.m.

The Pledge of Allegiance was given by all followed by a moment of silence and prayer.

Upon roll call Ron Williamson, David Fulling, Joe Bliss, Robin Guyer, Charlie Rains, Shirley Treadway and Gareld Bilyew were present. Chad Wells, Don Richart and John Sutfin were absent.

Gareld Bilyew made a motion to approve the minutes of the September 15, 2011 County Board meeting noting correction of concrete work on Court House/EMA building by board member David Fulling. Charlie Rains seconded the motion. Motion carried unanimously upon roll call.

Gareld Bilyew made a motion to approve the minutes of the September 15, 2011 County Board **closed** session meeting. Ron Williamson seconded the motion. Motion carried unanimously upon roll call.

Ron Williamson made a motion to approve the claims as presented except one. Robin Guyer seconded the motion. Ron Williamson, David Fulling, Joe Bliss, Robin Guyer, Charlie Rains and Shirley Treadway voted "aye". Gareld Bilyew voted "nay". Motion carried with 6 "ayes" and 1 "nay" (see Claims p.1156-1205)

Officer reports were given by Treasurer-Twyla Bailey, Supervisor of Assessments-Hope Weber, State's Attorney-Tom Wiseman, Public Defender- Matt Hartrich, Highway Secretary-Valerie Dunlap, EMA Coordinator-Kenny Prior, and County Clerk-Patty Lycan.

Treasurer-Twyla Bailey stated that the County Tax Sale is scheduled for November 18, 2011 at 2:30 p.m.

Shirley Treadway made a motion to approve the treasurer's report as presented. Ron Williamson seconded the motion. Motion carried unanimously upon roll call. (see Report p.1206-1212)

Patty Lycan, County Clerk addressed the board about the cost of running a half-page Plat Book Ad. We will be given a number of free plat books for running the ad. After discussion, Patty agreed to work with the company to negotiate the best price possible.

Gerald Bilyew made a motion for Patty to negotiate for the best price. Robin Guyer seconded the motion. Upon roll call Ron Williamson, David Fulling, Joe Bliss, Robin Guyer, Shirley Treadway and Gareld Bilyew voted "aye", Charlie Rains voted "nay". Motion passed with 6 "ayes" and 1 "nay". (Pricing Notice p.1213)

Hope Weber, Supervisor of Assessments, reported that the mapping project is finished. She also reported on the impact of the closure of the Hutsonville Power Plant on the Crawford County community. It's present assessed value is 1.9 million dollars. It comprises 0.5 % of our total tax income.

Matt Hartrich, Public Defender, reported on cases heard this month.

Mary Kindt of the Community Revitalization Committee asked for permission to put up the Christmas decorations again this year. She also asked for permission to do so annually without having to come to the Board every year.

Dave Fulling made a motion to allow the Community Revitalization Committee to decorate the Court House lawn for Christmas on an annual basis until terminated by either party. Charlie Rains seconded the motion. Motion carried unanimously upon roll call. (Request p.1215)

Dave Fulling submitted a bid of \$14,050 for the second half of the cement for the EMA building by Mr. Droste. Twenty yards of concrete will be donated by R & L and Droste will also donate some for the area by the doors. Shirley Treadway moved to accept the bid and Charlie Rains seconded the motion. Motion passed unanimously upon roll call. (Bid notice p.1216-17)

Ron Williamson passed out Animal Control Contract bid information. The Humane Society and City of Robinson are asking for more time to deal with the problems and work them into the budget. Nearby communities are being polled for their input. Their Contract renews December 1st. Tom Wiseman will research unincorporated areas. Other communities as well as ours need some lead time to deal with this problem. It was proposed that a letter be written to outline our plan and intent. It will be hand delivered, rather than mailed to the other communities so that more communication can result. Shirley Treadway and Ron Williamson agreed to deliver the letter and converse with them. Don Richart and John Sutfin will be asked to compose the letter.

Don Webb spoke about the budget. We are \$3,080 away from having a balanced budget. There still may be areas of the budget that need modification due to unforeseen or unfinished business. Charlie Rains made a motion to post the **CC and Forest Preserve 2011-2012 Budget & Appropriation Ordinances.** Robin Guyer seconded the motion. Ron Williamson, David Fulling, Joe Bliss, Robin Guyer, Charlie Rains, and Shirley Treadway voted "aye"; Gareld Bilyew voted "nay". Motion passes with 6 "ayes" and 1 "nay" (see Budget p.1218-1295)

Joe Bliss, Board Chairman noted the names submitted for Crawford County Health Department Board Re-appointments: Joe Bliss, Dr. David Rotman, John Newlin, and Bonnie Finn. (Letter p.1296)
