The members of the Crawford County Board met in regular session on Thursday, December 10, 2015. County Board Chair, Gareld Bilyew, called the meeting to order at 6:00 p.m.

Pledge of Allegiance was given by all, followed by a moment of silence and prayer led by Gareld Bilyew.

Upon roll call David Fulling, Kip Randolph, Allen Price, Toni Earleywine, Gareld Bilyew, Terry McCoy, Steve Rich, Clint Williamson, Shirley Treadway and Don Lachenmayr were present.

MINUTES

MOTION: Allen Price moved that the minutes of the November 12, 2015 board meeting be approved as presented. Don Lachenmayr seconded the motion. Motion carried unanimously upon roll call.

CLAIMS

MOTION: Terry McCoy moved that the Claims be approved as presented. Don Lachenmayr seconded the motion. Motion carried unanimously upon roll call. (Claims-Page 2015-1426)

OFFICER REPORTS

Officer reports were given by County Clerk, Fayrene Wright; County Sheriff Bill Rutan; County Treasurer, Twyla Bailey; Public Defender, Cole Shaner; County Engineer, Justin Childress; Supervisor of Assessments, Hope Weber; Coroner, Earl Deckard; Crawford County Development Director, Connie Calvert; and State's Attorney, Matt Hartrich. Written reports were also submitted by Crawford County Probation and the Regional Office of Education. (Reports-Page 2015-1489)

County Sheriff, Bill Rutan reported that all animal control calls are now going through Dispatch. They have already seen an increase in the number of calls. He has ordered a dart gun for the Animal Control Warden. He is also working on having panic buttons installed in the Annex after concern over an irate customer.

County Treasurer, Twyla Baily presented her Annual Report on the Range of Tax Rates per Resolution. The average county tax rate is 8.412 percent. The lowest rate is 6.4838 percent in Robinson Township, and the highest rate is 10.5328 percent in LaMotte Township. She made final distribution on November 30, 2015. The total collected for the County was 29.5 million. The total received for Personal Property Replacement Tax was \$336,173.13.

MOTION: Shirley Treadway moved to approve the Treasurer's Report as presented. Steve Rich seconded the motion. Motion carried unanimously upon roll call. (Report-Page 2015-1510)

County Engineer, Justin Childress reported that the Bridge in Martin Township is back under construction. The beams were set this week. Hopefully it will be open by the end of next week. The deck on the bridge by the school in Palestine was originally constructed to hold 72,000 pounds. The State now requires 80,000. The Federal government will not pay for the bridge to be redone with a deck designed to hold 72,000 pounds. He has asked for a variance for this bridge. A variance would be the ideal solution as a culvert is not economically feasible for this location. Motor Fuel Tax money from the State will be released. Checks should start being cut next week. He lastly presented the Resolution Authorizing Weight Limits on Roads and the Resolution for County Maintenance. The County Maintenance Resolution allows Motor Fuel Tax money to be spent.

CCDA Director, Connie Calvert reported that two of the three loans approved last month have been closed. The McNair's loan will probably not close until January.

State's Attorney, Matthew Hartrich presented the Resolution for Appellate Prosecutor.
