The members of the Crawford County Board met in regular session Thursday, November 10, 2011. Chairman Joe Bliss called the meeting to order at 6:00 p.m.

The Pledge of Allegiance was given by all followed by a moment of silence and prayer.

Upon roll call Ron Williamson, David Fulling, Chad Wells, Don Richart, Joe Bliss, Robin Guyer, John Sutfin, Charlie Rains, Shirley Treadway, and Gareld Bilyew and were present.

Gerald Bilyew made a motion to approve the minutes of the October 13, 2011 County Board meeting. Charlie Rains seconded the motion. Ron Williamson, David Fulling, Joe Bliss, Robin Guyer, Charlie Rains, Shirley Treadway and Gareld Bilyew voted "aye". Chad Wells, Don Richart and John Sutfin abstained. Motion carried with 7 "ayes" and 3 abstentions.

John Sutfin made a motion to approve the minutes of the October 13, 2011 County Board <u>Closed</u> session meeting. Gerald Bilyew seconded the motion. Ron Williamson, David Fulling, Joe Bliss, Robin Guyer, Charlie Rains, Shirley Treadway and Gareld Bilyew voted "aye". Chad Wells, Don Richart and John Sutfin abstained. Motion passed with 7 "ayes" and 3 abstentions.

Don Richart made a motion to approve the claims as presented. Shirley Treadway seconded the motion. Treasurer-Twyla Bailey stated that the County Tax Sale is scheduled for November 18, 2011 at 2:30 p.m. The final tax distribution will follow the tax sale in the last week of November.

Dave Fulling made a motion to approve the treasurer's report as presented. Charlie Rains seconded the motion. Motion carried unanimously upon roll call. (see Report p.1367-1371)

Twyla Bailey stated it was time to transfer \$7,500 from the CDAP Revolving Loan Fund to the General Fund for September, October and November.

Gareld Bilyew made a motion to transfer \$7,500 of CDAP Revolving Loan Funds to the General Fund. John Sutfin seconded the motion. The motion passed unanimously upon roll call.
