Minutes of Proceedings "1 of 3" Crawford County Board Thursday, June 13, 2019

The members of the Crawford County Board met in regular session on Thursday, June 13, 2019. County Board Chair, David Fulling, called the meeting to order at 6:00 p.m.

Pledge of Allegiance was given by all, followed by a moment of silence and then prayer led by Kip Randolph.

Upon roll call Koert Bartman, Kevin Morrison, George Bohman, David Fulling, Kip Randolph, Kevin Dart, Jonathon Goff, Clint Williamson and Jim Keller were present. Don Goupil was absent.

#### **MINUTES**

**MOTION:** Jonathon Goff moved to approve the minutes of the May 16, 2019 County Board meeting as presented. Kip Randolph seconded the motion. Motion carried unanimously upon roll call.

#### **CLAIMS**

**MOTION:** Jim Keller moved to approve May claims. Koert Bartman seconded the motion. Motion carried unanimously upon roll call. (Claims, Page 640)

**OFFICER REPORTS:** Officer reports were given by Treasurer, Twyla Bailey; County Sheriff, Bill Rutan by Deputy, Brent Dotson; CCDA Director, Alex Pleasant; State's Attorney, Matt Hartrich; and County Clerk, Fayrene Wright. Written reports were submitted by the Regional Office of Education. (*Reports, page 667*)

Treasurer Twyla Bailey reviewed reports. She reported that she had received June payments for the Commercium as well as State reimbursements for State's Attorney, Supervisor of Assessments and Public Defender for May. Twyla reported that tax bills were mailed yesterday. She mailed approximately 19,000 bills. Taxes totaled approximately \$32,000,000 for real estate and \$67,000 for mobile homes. The first installment is due on July 16 with the second installment due on September 6. The tax sale is scheduled for November 8, 2019 at 1:30 p.m. Twyla reviewed the Ordinance Setting the Date on Which Unpaid Taxes Become Delinquent. (*Treasurer's Report, page 686*)

County Clerk Fayrene Wright reviewed reports. She reported that real estate taxes were rolled to the Treasurer on May 30. Her office has started the process of purging voter registration as required by statute. Fayrene informed the Board that she has been notified the office will be receiving an additional \$3900 on the voter registration grant.
