The members of the Crawford County Board met in regular session Thursday, October 12, 2006. Chairman Joe Bliss called the meeting to order at 6:00 p.m.

Pledge of Allegiance was given by all.

Upon roll call Debbie Dix, David Fulling, Alyce Mullins, Richard Newbold, Don Richart, Tom Titsworth, Bob Tuttle, Ron Veenstra, Ron Williamson and Joe Bliss were present.

Bob Tuttle made a motion to approve the minutes of the September 14, 2006 board meeting with the correction of Ron Veenstra voting "aye" on the County Board Rules on page 3. Richard Newbold seconded the motion. Motion carried unanimously upon roll call.

Bob Tuttle made a motion to approve claims. Richard Newbold seconded the motion. Motion carried unanimously upon roll call. (see claims 1069-1129)

Officer reports were given by Treasurer-Doris Tracy, Sheriff-Todd Liston, Coroner-Earl Deckard, Supervisor of Assessments-Betty Bailey, Superintendent of Highways-Justin Childress, State's Attorney-Jay Holtzhouser, Public Defender-Matt Hartrich, Probation Officer-Betty Vandevender and County Clerk-Patty Lycan.

Ron Veenstra made a motion to approve the treasurer's report as presented. Richard Newbold seconded the motion. Motion carried unanimously upon roll call. (see reports 1130-1133)

Supervisor of Assessments-Betty Bailey presented a copy of fee schedule to board members. This will be placed on the agenda for November board meeting. (see 1134)

Ron Veenstra made a motion to allow the Supervisor of Assessments-Betty Bailey to sell the mapping information to Navteq for \$1,000. Alyce Mullins seconded the motion. Motion carried unanimously upon roll call. (see request 1135)

Bob Tuttle made a motion to approve the IDOT Audit Reports #74 and #53. Richard Newbold seconded the motion. Motion carried unanimously upon roll call. (see reports 1136-1160)

State's Attorney-Jay Holtzhouser reported on the RHSP fund. At this time all the money (\$30 million) is just sitting in the fund. No one is receiving any funding until at least late August or September 2007.

County Clerk-Patty Lycan reported that absentee, early and grace period voting has started in the Clerk's office.

The Health department had a short fall of \$18,000 from the appropriation and levy amount that was requested last year. State's Attorney, Jay Holtzhouser recommended increasing the levy for the next year to allow for shortfall.
